STUDENT DRIVER REGISTRATION FORM

PARKING A CAR ON SCHOOL GROUNDS IS A PRIVILEGE. STUDENTS WILL LOSE THE PRIVILEGE OF PARKING ON SCHOOL GROUNDS IF THEY FAIL TO CONFORM TO THE RULES/REGULATIONS BELOW:

1. Complete the form below. Obtain a **nonrenewable** parking tag from the main office each September.
2. Pay a Fifty-dollar (\$50.00) **non-refundable** fee. (Lost tag must be replaced)
3. **ATTACH THE PARKING TAG TO THE REARVIEW MIRROR.**
4. Safe operation of the vehicle must be observed at all times. Speed on school grounds must not exceed fifteen (15) M.P.H. whether or not posted.
5. No motor vehicle may be occupied while parked on school grounds during the school day.
6. A dismissal pass must be obtained from the attendance office in order to be dismissed during the school day.
7. Neither the school administration nor the school committee assumes any responsibility for damage to vehicles and/or to personal property items contained therein. **ALL VEHICLES PARKED IN THE STUDENT PARKING LOT SHOULD BE LOCKED.**
8. No car may break through the lines of departing buses during dismissal time.
9. Any reckless or careless driving as witnessed by any school staff members will result in parking privileges being revoked.
10. No students are to congregate in the parking lot at the beginning and/or at the end of the school day. Students are required to enter the building and/or exit the parking lot immediately.
11. **STUDENTS ARE REQUIRED TO PARK IN THE DESIGNATED STUDENT PARKING AREA.**
******PLEASE NOTE: THE RESIDENTIAL AREAS SURROUNDING THE SCHOOL ARE TOWN PERMIT PARKING ONLY.******
 Failure to adhere to this policy will result in the suspension of parking privileges. All unauthorized vehicles will be reported to the police and may be towed at the owner's expense
12. **AS A CONDITION OF THE PARKING PRIVILEGE, A STUDENT MUST CONSENT TO HAVING HIS/HER PERSONAL VEHICLE SEARCHED WHEN THERE IS REASON TO SUSPECT THAT A VEHICLE CONTAINS ILLEGAL SUBSTANCES AND/OR OTHER ILLEGAL MERCHANDISE. REFUSING CONSENT WILL BE CONSIDERED AN ADMISSION OF GUILT.**
13. **SOMERSET POLICE PERIODICALLY MONITOR THE SCHOOL GROUNDS AND MAY ISSUE PARKING TICKETS WITHOUT PRIOR NOTICE.**
